The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the final arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

To provide the services requested, it is necessary for financial arrangements to be settled before the remains are casketed or cremated. We accept cash, visa, master card, money orders, and cashier's checks. We do not offer payment plans nor accept postdated checks.

## Professional Services

Basic Services Fee of Funeral Director and Staff, and Overhead..... \$ 995.00

Our basic services fee includes: 24 hour availability of staff to respond to initial request for service; on-line, phone or **in-home arrangement conference** (Orange County location); planning selected tribute ceremony; securing vital statistics; preparing all state and federal documents, coordination with cemetery, crematory, and other third parties; overhead costs such as insurance, maintenance, utility, secretarial, administrative, and office equipment expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains).

Prepare and Obtain Disposition Permit & Death Certificate ..... \$ 75.00

Orange County hand-filing of Documents (ship-in) ..... \$ 125.00

Re-file Permit/Amend Death Certificate..... \$ 85.00

At our discretion insurance policy assignments may be accepted. A fee will be charged for the filing of forms. Assignments, if accepted, would include professional services and merchandise only. All cash advance accommodations and sales tax would be paid at the time of services and not included in the assignment.

Scattering of Cremated Remains at Sea (Non-witness, from OC shoreline) ..... \$ 125.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Removal of Implanted Devices such as a Pacemaker ..... \$ 125.00

Expedited Cremation fee ..... \$ 295.00  
*(Cremation within 48 hours of receiving necessary permits and authorizations)*

Decedents with weight exceeding 300 lbs. will incur additional fees as set forth by the crematory due to limitations and restrictions on the cremation chamber, and the need for an alternative container suitable for weight restrictions.

*Funeral or Memorial Services exceeding 2 hours will incur additional charges at the rate of \$175.00 per hour or portion thereof. Evening visitation or memorial ceremonies end at 8:00 PM.*

**Receiving of Remains from another Funeral Provider** ..... \$ 1,495.00

*Includes our basic service fee of funeral director, staff, and overhead, transfer of remains (from within Orange County, SNA or LAX) to holding facility, use of utility vehicle to transport to local cemetery, other preparation of remains, securing a final disposition permit. Visitation and rites of ceremonies can be selected at an additional cost.*



**Forwarding of Remains to another Funeral Provider ..... \$ 2,275.00**

*Includes our basic service fee of funeral director, staff, and overhead, transfer of remains (Orange County) to our holding facility and to the airport (SNA or LAX), other preparation of remains. This charge does not include: airfare or casket. Visitation and rites of ceremonies can be selected at an additional cost. The deceased remains is packed in dry ice as mandated by transportation authorities.*

**Direct Cremation (without ceremony)** .....Price range is \$ 690.00 to \$ 737.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.

Direct Cremation with container provided by purchaser ..... \$ 690.00

*An alternative container provided by purchaser must be one that can be closed, is leak-resistant, combustible, and must be acceptable by crematory. The purchaser assumes responsibility for suitability and fitness of container and agrees to hold Fond Remembrance Cremation Services, Inc., harmless for damages that might result from the use thereof.*

Direct Cremation with a fiberboard alternative container ..... \$ 737.00

Direct cremation includes: Basic services of funeral director, staff and overhead; on-line, phone, or in-home consultation; transportation of remains from a place of death within Orange County, CA to our secure holding facility and then to an Orange County crematory; Sheltering the decedent in refrigeration (up to 5 consecutive days); placement of body into an alternative container (fiberboard); prepare documents required for cremation; crematory fees; and a durable cremated remains container (plastic utility urn).

This service option is provided for at the convenience of Fond Remembrance Cremation Services, Inc. once all legal requirements are completed. Cremated remains are generally available within 15 days from date of permit filing, but can take longer. Decedents in weight exceeding 300 lbs. will incur additional fees as set forth by the crematory due to limitations and restrictions on the cremation chamber, and the need for an alternative container suitable for weight restrictions.

The deceased remains are not dressed but this service can be provided for at an additional fee. Memorial services are not offered with this service option, but can be provided for by selecting another service option that offers that provision.
